

HST 25th Anniversary NYC Trip

December 30, 2019

There is limited space on the bus. Applications will be accepted first come/first serve basis.

Christmas in NYC Anniversary Trip details:

- Date: Monday, Dec. 30 - depart 7am and return 11:30PM
- Cost is \$200 (non-refundable). You can make up to 4 payments by writing pre-dated checks that are mailed in with 3 papers: Registration Form, Signed Guidelines, Signed Release.
 - Four checks should be dated: August 20, Sept. 20, Oct. 20, Nov. 20.
 - Note: if something comes up so that you can no longer attend, HST will send an email to see if someone else in HST would like to buy your slot from you.
- Cost includes: transportation, ticket to tour Radio City Music Hall, orchestra ticket to see 5pm *Rockette's Christmas Spectacular Show*, and NY pizza/drink/dessert for bus ride home.
- The first 56 people to register are guaranteed a slot. After that, we need an additional 30 people (to fill a 2nd bus). If we don't get enough to fill the 2nd bus, money will be refunded.
- Maps and detailed instructions will be provided so participants can watch the ball drop in Times Square (test-run happens at Noon on Dec. 30), do the walking tour for the famous animated store windows, see Rockefeller Center and shop in some of NYC's famous stores.

Eligibility:

- Current HST families and HST alumni families who meet age requirement.
- Current HST teachers/directors.
- Age (by Dec. 31, 2019) requirements:
 - Age 19 and up - must have one person to tour with.
 - Age 15-18 need parent signature to tour in group of 3 to 6 high school students.
 - Age 13 & 14 need an adult chaperone for a group of 4 students.
- Siblings can be a chaperone if they are age 21 or older. Chaperones pay for their trip.

- _____ I agree to pack a lunch/drink for the ride to NYC.
- _____ I agree to stay with my designated group while touring NYC.
- _____ I agree to tour within the designated areas marked on the map that will be provided (Times Square, Rockefeller Center, animated Christmas Store Window Walking Tour, Radio City Music Hall).
- _____ I agree to read/follow email instructions about what to wear & what items to bring.
- _____ I am aware that NYC can be bitter cold in December, particularly if it is windy. I take full responsibility for providing/wearing appropriate winter garments.
- _____ I agree to keep cell phones on (if owned), and to participate in hourly pictures that will be sent to leaders to confirm group's location.
- _____ I agree to contact trip leaders if my group encounters a problem or becomes uncertain about our location and directions.
- _____ I agree to be at Radio City Music Hall at my groups assigned tour time.
- _____ I agree to pick-up my ticket for the 5pm Christmas Spectacular Show at 4:30pm.
